**Whereas** the church, person, or organization named below ("Partner") desires to utilize and license branding, logos, web-site content, and other materials owned by We Happy Few, Inc., headquartered at 15870 Open Sky Way, Colorado Springs CO 80908 (dba "Band of Brothers"), in order to partner with the Band of Brothers' organization to promote the Partner's mission - which Partner agrees is consistent with the following Band of Brothers' mission:

*To offer the Brotherhood of Christ to men fighting to move from success to meaning,  
addictions to freedom, and self-orientation to God's priorities.*

**Therefore**, Partner hereby agrees to the following terms and conditions ("Agreement"):

**1. Ownership of Intellectual Property.** Partner acknowledges that the Band of Brothers' logo, the sword-shaped celtic cross, and the silhouette of men are trademarks of We Happy Few, Inc. (dba "Band of Brothers"). Additionally, the Band of Brothers' poster (which includes the aforementioned trademarks) and all other content and written material on the Band of Brothers' website (collectively the "Materials") are the property of Band of Brothers and are protected by copyright, trademark, and other intellectual property rights pursuant to the laws of the United States and International Treaties. Accordingly, nothing herein grants nor assigns any intellectual property rights to Partner nor its members and affiliates and the Materials may not be copied, duplicated, displayed, presented, or distributed except as expressly provided herein.

**2. Partner use of Intellectual Property.** Partner is granted the limited right and license to use the Materials for the express purpose of promoting its ministry and its partnership with the Band of Brothers' ministry pursuant to the following requirements:
